Wolno:



kopiować, rozpowszechniać, odtwarzać i wykonywać utwór



tworzyć utwory zależne

Na następujących warunkach:



Uznanie autorstwa — Utwór należy oznaczyć w sposób określony przez Twórcę lub Licencjodawcę



Użycie niekomercyjne — Nie wolno używać tego utworu do celów komercyjnych.



Na tych samych warunkach — Jeśli zmienia się lub przekształca niniejszy utwór, lub tworzy inny na jego podstawie, można rozpowszechniać powstały w ten sposób nowy utwór tylko na podstawie takiej samej licencji.

Ze świadomością, że:

Zrzeczenie — Każdy z tych warunków może zostać **uchyleny**, jeśli uzyska się zezwolenie właściciela praw autorskich.

Public Domain — Jeżeli utwór lub jakiegokolwiek jego elementy, zgodnie z prawem właściwym, należą do **domeny publicznej**, to licencja w żaden sposób nie wpływa na ten status prawny.

Inne prawa — Licencja nie wpływa w żaden sposób na następujące prawa:

- Uprawnienia wynikające z **dozwolonego użytku** ani innych obowiązujących ograniczeń lub wyjątków prawa autorskiego.
- **Autorskie prawa osobiste** autora;
- Ewentualne prawa osób trzecich do utworu lub sposobu wykorzystania utworu, takie jak **prawo do wizerunku** lub prawo do prywatności.

Uwaga — W celu ponownego użycia utworu lub rozpowszechniania utworu należy wyjaśnić innym warunki licencji, na której udostępni się utwór.

Pewnie w głowach wielu pojawi się pytanie: dlaczego i po co ta licencja? Otóż jest ona po to, aby chronić prawa autorów oraz gwarantować pierwotną idee wydania (opracowania) tej książki szachowej:

Książka w zamierzeniu ma być projektem niekomercyjnym (a więc nikt na niej nie zarabia – w szczególności nikt kto nie jest autorem danej części pracy) oraz dostępnym dla wszystkich zainteresowanych (a taką opcję umożliwia dostęp za pośrednictwem sieci Internet – w formacie plików PDF, które mogą być otwierane za pomocą darmowego oprogramowania, np. Foxit Reader → niewielki, szybki i prosty w obsłudze; jest on do ściągnięcia pod poniższym adresem: <http://www.foxitsoftware.com/pdf/reader/addons.php>). Ponadto autorzy poszczególnych prac mają mieć pewność (a to daje ta licencja), że stworzone przez nich opracowania nie zostaną przywłaszczone przez innych (jako podawanie się za autora pracy, kiedy autorem się nie jest; nie zaś możliwość korzystania z twórczości pracy autora). Ponadto licencja gwarantuje, że nikt nie będzie mógł po wykorzystaniu naszej pracy (całości lub części) rozpowszechniać na innych zasadach niż ta licencja.

A co jeśli jestem zwykłym szachistą lub osobą, która chce wykorzystywać tę pracę (całość lub fragmenty) na własny użytek?

Tak długo jak akceptujesz i przestrzegasz warunków licencji, tak długo możesz wykorzystywać naszą pracę. Jeśli więc chcesz ją mieć na własny użytek lub podzielić się nią z kolegą czy osobą, która poszukuje informacji na tematy poruszane w tej publikacji... to śmiało możesz to zrobić!

I na koniec podsumowując: to co podano na samej górze w rubryce:

- „Wolno” → opisano co jest dozwolone
- „Na jakich warunkach” → opisano jakich warunków musisz przestrzegać
- „Ze świadomością, że”: → opisano najważniejsze szczegółowe warunki

Mam nadzieję, że warunki licencji są dla ciebie jasne. Jeśli nie do końca i masz wątpliwości, wówczas zapytaj kogoś kto potrafi ci to lepiej wyjaśnić (np. znajomego lub prawnika).
